### Zoom integration:

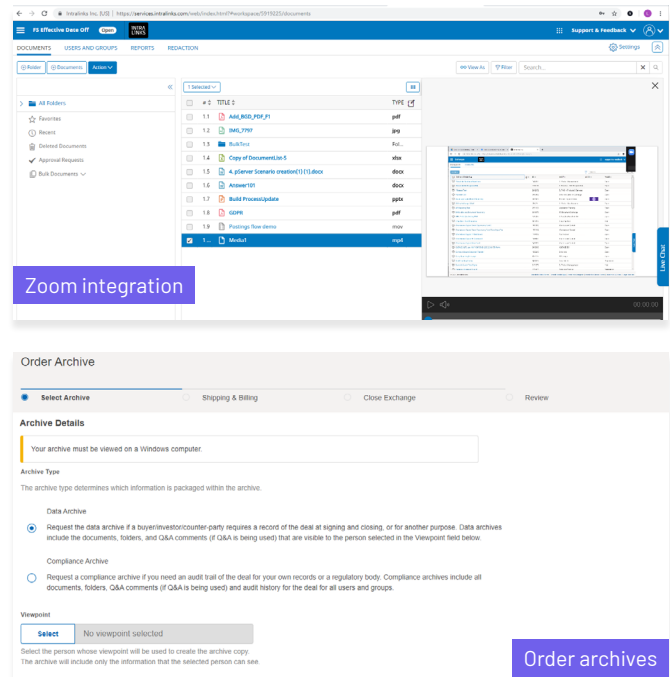
Easily upload Zoom recordings to the VDR – investor presentations, site visits, due diligence reviews, Q&A sessions and more.

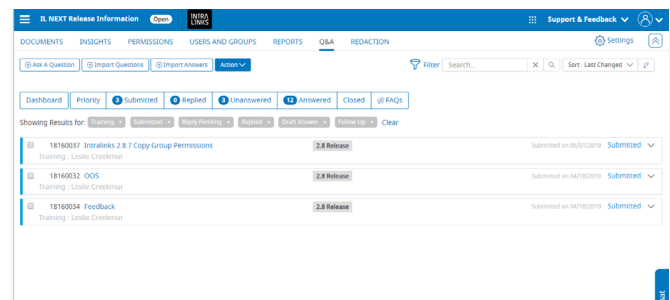
## Streamline communication

### Redaction:

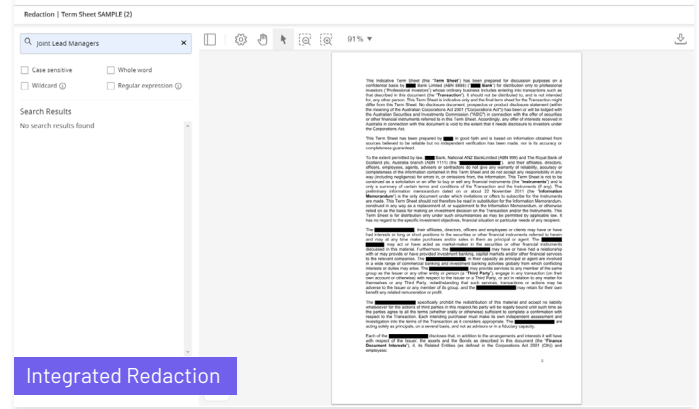

### Ai Redaction:

- Artificial intelligence makes the process even more efficient. Let our AI engine identify MNPI and PII; you simply review and confirm, then initiate redaction across the documents, all from within the VDR.

### Prevent download:

- When documents need to be view-only, regardless of the user's access type, our enhanced document viewer ensures those files are never downloaded from the VDR.



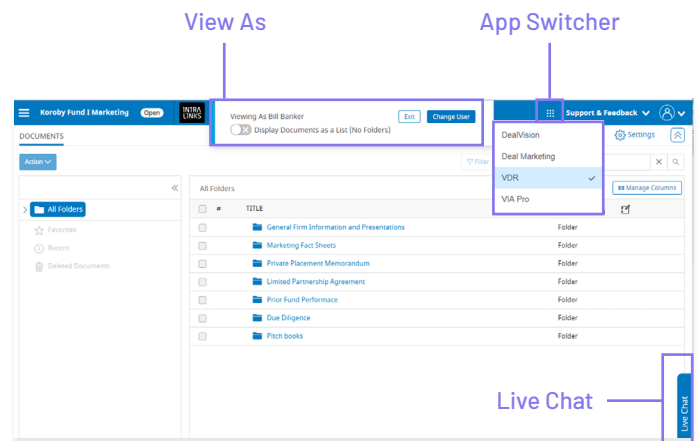
### Workflow:
